Precursors Producer-Importer, called IP-Precursors, shall mean any such pharmaceutical company or such other industry which uses precursors as raw material or agents in its industrial processes, and which has been given recognition to import precursors to meet its own needs.

Precursors Registered-Importer, hereinafter called IT-Precursors, any such company which carries out precursors trading activities and has obtained the designation to import precursors to be distributed to pharmaceuticals and other industries as end-users of precursors.
